Subject: Election of Office Bearers and Executive Committee Members for the Term 2023-2024

- 1. In exercise of the powers conferred by Rule 25B of the Memorandum of Association and Rules & Regulations of the Delhi Printers' Association and in pursuance of the resolution passed by the Executive Committee of Delhi Printers' Association at its meeting held on the March 20, 2023. I, Mukesh Kaushik, Returning Officer, along with my Co-Returning Officer Mr. Sunil Jain, for conducting election for the term 2023-2024, hereby notify that election office will function at **Flat No. 26-A, Block No. 4, Shankar Market, New Delhi-110001** from March 24, 2023 till election results are announced.
- 2. The election of the office bearers viz. President, three Vice-Presidents, Hon. General Secretary, two Joint-Secretaries, Treasurer and twenty Executive Committee Members of the Association for the term 2023-2024 will be held on Sunday 16th April, 2023 at DPA Office, Flat 26-A, Block No. 4, Shankar Market, Connaught Circus, New Delhi 110 001.

The programme for election will be as under:-

Date of Election Sunday 16th April, 2023 from 10.00 am - 5.00 pm

Venue of Election: DPA Office, Flat 26-A, Block No. 4, Shankar Market, Connaught Circus, New Delhi - 110 001.

- 3. Only those members (printers) shall be entitled to contest the election or vote who have paid their Annual Subscription within the prescribed date i.e., 31.01.2023. **A list of such voters** on good standing is being sent herewith.
- 4. Objections, if any, regarding the Voters List must reach the Returning Officer with documentary evidence supporting their point by **31st March**, **2023** at the latest. No objections will be entertained thereafter.
- 5. A member can file nomination paper for the post of one office only. He can, however, file nomination paper for membership of the Executive Committee also in addition to one post of office bearer.

- 6. A copy of blank nomination paper is enclosed. More copies can be had from the DPA office or may be photocopied, if needed.
- 7. In pursuance of sub-rule 25B(e) of Memorandum of Association and Rules & Regulation of the Delhi Printers' Association, at the time of filing of nomination for Executive Member or Office Bearer, the candidate should have an operational plant of printing trade in the Union Territory of Delhi or if outside Delhi, he should fulfil the requirements as per clause 3 of this Rules and Regulations, meaning that he should not cease to be a member of this association, as per this clause and can be nominated as a candidate for the post of Executive Member or Office Bearer. The candidate should have remained as a member of DPA for at least one year.
- 8. In pursuance of sub-rule 25B(h) of Memorandum of Association and Rules & Regulation of the Delhi Printers' Association, a deposit of Rs.500/- paid in cash or through bank draft shall be submitted with each nomination paper by the candidates contesting for any post in the annual election. Deposit shall be forfeited if the candidate is unable to secure 20% of the total votes polled.
- 9. Deposit shall be refunded to the candidates obtaining 20% or above of the total votes polled and also to candidates who withdraw their nomination papers by the date and time specified for the purpose in this election notice.
- 10. All papers including nomination papers meant for the Returning Officer shall be delivered at the said office in closed envelopes superscribed with the words "Nomination Papers" latest by Monday 03-04-2023 by 2.00 p.m.
- 11. Members desirous of being present at the time of scrutiny of nomination papers are welcome to do so.
- 12. Only such members whose nomination papers complete in all respects are received in time and found in order shall be eligible to contest the election.
- 13. Final list of eligible contestants shall be displayed in the Office of Returning Officer on **07-04-2023** at **5 p.m.**
- 14. The election of the Executive Committee members shall be held simultaneously with that of the office bearers.
- 15. The names of successful office bearers who may simultaneously be elected to the Executive Committee shall be removed from the list of elected Executive Committee members. The consequent vacancies shall be filled in by the members who may have polled next highest number of votes.
- 16. Members are advised to bring their association membership card or passport or driving licence or Aadhar card or any other proof bearing their photo with them to facilitate election. Those members who do not have their association membership card may request the association office to issue the same. Please send a photograph for doing the needful.

17. Display of posters, banners and shouting of slogans are strictly prohibited.
