## Report on Annual General Meeting of DPA Held on April 19, 2025

The Annual General Meeting of Delhi Printers Association was held at Malviya Smriti Bhawan on April 19, 2025.



The former President of DPA Mr. Sunil Jain greeted the members and thanked them for sparing time to attend the AGM in a large number. He requested the DPA President Mr. Puneet Talwar and other office bearers to take their seats on the dais.

Mr. Dayakar Reddy, head of Sai Enterprises which sponsored the AGM, was invited to give his PowerPoint

presentation to the audience. Mr. Reddy said that Sai Enterprises is

an old Post Press Graphic Machinery Supplier Company and that a number of well-known DPA members are already their regular clients for long. During the presentation he kept on answering the significant role played by Sai's latest post press equipment. Mr. Reddy extolled the important support of DPA in his business. Thanking Mr. Reddy for sponsoring the AGM, DPA functionaries honoured Mr. Reddy with a bouquet and a



memento. Former President of IPAMA Mr. Rakesh Sodhi also felicitated Mr. Reddy.



In his welcome address Mr. Puneet Talwar expressed his gratitude to the members for reposing their confidence in him and for electing him as President for the 2024-2025 term. He said he sincerely values the cooperation, support and suggestions he received from them, due to which he and his team could organise an unprecedented number of activities of the association highly successfully and take essential decisions for the betterment of the association as well as the members. He said though the Hon. General

Secretary Mr. Sandeep Aggarwal would present his detailed report on the activities of Delhi Printers Association during the outgoing year, he would like to briefly

highlight the main activities of the association: - Havan as well as the 78th Independence Day celebrations at DPA's newly acquired Printers Bhawan; Global Summit of Print Industry Leaders; co-hosted the Business Outlook Print Summit; held a number of technical Seminars; celebrated Printers' Day; organised a group tour of members to visit the China Print 2025 exhibition in Beijing in May; held DPA's flagship Holi Milan-2025, and above all for the first time in DPA's history it distributed its Diary-2025 and Calender-2025 to all members as New Year gifts.

Mr. Puneet Talwar then requested the Hon. General Secretary to present his Annual Report for 2024-2025.

Mr. Sandeep Aggarwal welcomed the members to the AGM and thanked them for



their big presence. Firstly, he condoled the demise of DPA members and their relatives during the outgoing year and read out their names as listed in Annexure 'A'. At his request the audience stood up in silence for two minutes to pray for the eternal bliss of the departed souls.

On the advice of the audience the Hon. General Secretary Mr. Sandeep Aggarwal read out only the important parts of the main activities and other achievements of the association during the outgoing year 2024-2025. He said

he has special praise for the Hoii Milan Chairman Mr. Mukesh Kaushik and his wonderful team for the extraordinary success of the 'Khelo Rang - Hamare Sang' function. Mr Sandeep Aggarwal has a unique flair to speak and to put forth his views with interesting anecdotes and a touch of intermittent sher-o-shayri. He read out the report in his ideal individual style which was responded with profuse clappings from the audience.

When the matter of Consideration and Adoption of the Report on the Working of the Association During the Year 2024-2025 was raised Mr. Arun Berry proposed it and the members adopted it unanimously by raising their hands.



Later on, Mr. Sandeep Aggarwal sought Confirmation of Minutes of the last Annua 1 General Meeting of DPA held on 20.04.2024. The Minutes of the last AGM were



confirmed as proposed by Mr. Mukesh Kaushik and seconded by Mr. Vijay Mohan.

The Treasurer Mr. Prashant Aggarwal presented the Audited Statement of Accounts for the year 1st April 2023 to 31st March 2024 stating that the accounts had already been circulated and sought their Consideration and Adoption. As there was no query the Accounts were adopted when Mr. Rajesh Sardana proposed it and Mr. Mukesh Kaushik seconded. Mr. Prashant Aggarwal added

that he would like to thank everyone, especially Mr. Vijay Mohan and Mr. Mukesh Kaushik, Mr. Sandeep Aggarwal, Mr. Deepak Bhatia and other colleagues for helping the association collect huge sponsorship amounts for Holi Milan 2025. He seemed sure that similar financial support would be available in future also.

When the agenda item Ratification of the Amendments in Constitution of Delhi

Printers Association in the Special General Body Meeting came up, Mr. Vijay Mohan explained that DPA had discussed this matter of the necessary Amendments during the Executive Committee Meeting held on April 11, 2025 and due approval secured from the EC members. Subsequently, the Amendments were duly approved at the Special General Body Meeting of DPA that was held only 30 minutes ahead of that day's AGM. The decisions arrived at as Amendments were ratified when the same were



intimated to the AGM audience who gave their unanimous approval with raised hands. The new rules would come into force from that day onward.

Soon after the agenda of the AGM, the Returning and Co-Returning Officers of



DPA's Election for the 2025-2026 term Mr. Mukesh Kaushik and Mr. Sunil Jain went to the podium to announce the results of the Annual Election for the forthcoming 2025-2026 term. After giving details of the process of filing and scrutiny of nominations Mr. Mukesh Kaushik told that since only 28 nomination papers were received for the 8 seats of Office Bearers

and 20 seats of

Executive Committee, there was no contest and the new team was unanimously elected for 2025-2026. He read out the names of the elected team and invited them one by one to the dais for welcome with garlands and a group photograph. Among them were Mr. Sandeep Aggarwal-President, Mr. Prashant Aggarwal-Hon. General Secretary and Mr. Deepak Bhatia-Treasurer. The newly-elected






team received a resounding welcome by outgoing Office Bearers and senior former Presidents.

The outgoing President for 2024-2025 Mr. Puneet Talwar was warmly felicitated with a memento and a shawl by former Presidents in recognition of his exemplary stewardship, remarkable decisions and raising the benchmark of DPA's achievements.

While giving the Vote of Thanks Mr. Vijay Mohan expressed his gratitude to the DPA

He said DPA is not going to stop now as it has started on a progressive fast track. It already has a proper office of AIFPP in its Printers Bhawan and it plans to



acquire more similar property soon. Mr. Vijay Mohan greatly appreciated the previous team of DPA for holding such a large number of national and international events and hoped that the incoming team will perform better. On behalf of other former Presidents, he blessed the new EC body.

The AGM concluded with high tea.
